Mission of the Department

Mounting collaboration between European governments and organizations has major consequences for life of citizens within the Member States. It is expected that the role of the EU will increase in the years to come.

The consequences are apparent from the way in which health and healthcare are considered and discussed internationally, within Europe and nationally.

Growing European-level involvement can be observed in today's research agenda, fostering the concept of a European Research Agenda. Education

BSc in European Public Health

Since the academic year 2006/2007, the Faculty of Health, Medicine and Life Sciences of Maastricht University offers a unique multidisciplinary and internationally focused bachelor programme, entitled Bachelor in European Public Health (B-EPH). This fully English taught programme is formally accredited by the Nederlands Vlaamse Accreditatie Organisatie (NVAO).

The EPH bachelor programme is the first in Europe to extend beyond national borders and looks at every aspect of European health and healthcare. The EPH graduate knows when, where and how to intervene on a European scale. The Bachelor's programme in EPH has a practical orientation and the tutorial groups make frequent use of real-life issues. EPH students explore modern-day European public health issues and the European agenda for public health, the organization of healthcare in Europe, European public health targets and the proposals for change these have prompted. The approach used is multi-disciplinary in nature. In addition, the programme uses a wide variety of teaching methods, including lectures and seminars given by national and international guest speakers, role playing, excursions, presentations by students, literature studies and project-based interactive tutorial groups.

MSc in European Public Health

Starting in the academic year 2009/10, the Maastricht University Medical Centre and the Faculty of Health, Medicine and Life Sciences offer a new master's programme: the Master of Science in European Public Health. An English-taught, multidisciplinary and internationally focused degree.

The mission of this programme is to help students to obtain the skills and knowledge to compare health and healthcare in various settings, to search for and identify best practices, to foster the transfer of the best practices and to advise on, innovate and implement best practices in new situations.

The focus of the master in EPH will be geared towards:

- the situations, determinants, interventions and practices relevant to the health status of populations, of groups within them, and between member states;
- the diversity of practices and ways of organizing healthcare and systems for care provision in Europe;
- the demand by European institutions for modern, scientifically educated professionals with analytical tools and innovative research instruments to help them operate effectively in national, international and supranational policymaking and organizational development in the field of health.
